4. Very limited Hall accommodation is available for full-time Higher Degree students and will be allocated on the basis of first-come first-served. 5. You are required to register for your Programme of study within six weeks of the beginning of the academic year and renew your registration annually until you finally complete the programme. Late Registration after six weeks will automatically attract penalty.
